# MODERN SLAVERY ACT STATEMENT

#### Introduction

OneAdvanced is committed to a transparent approach in combating modern slavery and human trafficking within our operations and supply chains. Under relevant legislation, including the UK Modern Slavery Act 2015, we actively address any risks of modern slavery within our operations, aligning with similar regulatory frameworks globally. This statement outlines our proactive steps to mitigate such risks and our continued commitment to upholding ethical standards.

## **Our Position on Modern Slavery**

Though software-focused industries typically present lower risks, OneAdvanced is committed to understanding and addressing any potential vulnerabilities in our supply chain. Our business model largely relies on a highly qualified workforce directly employed within OneAdvanced, with stringent employee policies ensuring fair treatment and compliance with minimum wage standards.

#### **About OneAdvanced**

As a key provider of industry-focused software solutions, OneAdvanced operates across core markets such as Education, Health, Social Care, and IT Services. We are driven by our core values of Accountability and Integrity, ensuring fair and respectful treatment across all facets of our organization together with our ESG strategy which is driven by our vision to reduce inequality and better society.

## **Business and Supply Chain Oversight**

We have a zero-tolerance policy towards modern slavery and human trafficking in all areas of our supply chain, as reflected in our Supplier Code of Conduct. While our direct risk is comparatively low, we acknowledge the importance of vigilance and aim to partner with suppliers who share our commitment for ensuring that supply chains reflect OneAdvanced's high standards for business ethics, integrity and respect for human rights and ensuring the absence of slavery and human trafficking in their supply chain. Our commitment includes a structured approach to supplier assessment, utilizing standardized contracts and engaging with suppliers—primarily reputable multinationals—who align with our ethical standards.

#### Policies, Due Diligence and Effectiveness

Our hiring processes ensure lawful employment, prohibiting underage labour and providing competitive wages. Employees are further supported through comprehensive onboarding, Modern Slavery training, and ongoing development opportunities. Our company HR policy guides all employees in maintaining ethical standards, and mandatory e-training on modern slavery issues through our SkillsHub online learning platform.

As part of our efforts to monitor and reduce the risk of slavery and human trafficking occurring within our supply chains, our due diligence includes:

- Financial stability assessments
- Regulatory compliance checks
- Verification of anti-corruption policies
- Implementation of business continuity plan

Our due diligence is designed to: 1) establish and assess areas of potential risk in our business and supply chains, 2) monitor potential risk areas in our business and supply chains, 3) reduce the risk of slavery and human trafficking occurring in our business and supply chains and 4) provide adequate protection for whistleblowers.

### **Measuring Our Effectiveness**

To assess the effectiveness of our actions in combating modern slavery, OneAdvanced has established the following Key Performance Indicators (KPIs):

- Number of employees trained on identifying and preventing modern slavery.
- Regular review of material suppliers in our supply chain.

## **Training**

OneAdvanced maintains policies and procedures within its People function which deal with matters such as treating employees fairly, protecting human rights such as elimination of discrimination. All new starters are provided with full on-boarding including training on Modern Slavery (Modern Slavery UK/EU). Refresher training is available to all staff at any time via the Advanced Thinking Online platform to emphasise the importance of integrity in the workplace.

As with any company policy, disciplinary procedures are included which reflect the process in the event of any violation of legislation or the OneAdvanced's policies in relation to it.

## **Future Goals**

OneAdvanced aims to embed these standards further by enhancing our supplier engagement process and setting clear, measurable targets to uphold our standards across new and existing partnerships.

## **Board Approval**

This statement has been approved by the Board of Directors of OneAdvanced and will be reviewed and updated annually to reflect ongoing improvements in our processes and our commitment to combating modern slavery.
