In the lead-up to hard close, the LMS is used to check that all co-investment data, evidence and receipts are recorded correctly, making use of the consistency that comes from having all this data in one system.

Using file uploads, custom learner statuses and Destination and Progression data capture, LMP now track each learner from the moment they are entered into the system until they leave, with any potential audit gaps filled using our functionality.
