EMIS LICENCE TERMS

The EMIS Drug Database software is a third party software product licensed by Egton Medical Information Systems Limited.

A Customer's use of the EMIS Drug Database software is governed by the terms of the End User Licence Agreement set out below.

EMIS Licence Agreement

BEFORE YOU INSTALL THE SOFTWARE, CAREFULLY READ THE TERMS AND CONDITIONS OF THIS LICENCE. BY CLICKING ON THE "ACCEPT" BUTTON AND BY INSTALLING THE SOFTWARE YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING THE LICENSEE TO THIS LICENCE. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS LICENCE, DO NOT INSTALL OR USE THE SOFTWARE.

When you "click" the "Accept" button, Egton Medical Information Systems Limited of Rawdon House Green Lane, Yeadon Leeds LS19 7BY (the "Licensor") grants you (the "Licensee") a non-exclusive, non-transferable Licence for the accompanying software product, the EMIS Drug Database including (if applicable) electronic documentation and associated material (the "Software"). The Licence permits you to "Use" (as hereinafter defined) the Software on a single computer system (the "System") upon the terms and subject to the conditions contained herein.

1. In this Licence "Use" shall mean and include utilisation of the Software by copying, transmitting or loading the same into the permanent memory (e.g. hard disk, CD-ROM or other storage device) of the System for the processing of the System instructions or statements contained in such Software; and copying the Software which is in machine-readable form for Use by the Licensee on the System for the purposes only of understanding the contents of such machine-readable material. One (1) copy of the Software may be made for back-up and one (1) copy for disaster recovery provided they contain the same copyright information as the original.
2. The Software is NOT free or shareware. The Licence Fee is annually renewable and paid on your behalf by Advanced Health and Care Limited.
3. Upon accepting this Licence you undertake:
